GREEN BAY, WI -- Kristina Shelton, candidate for Wisconsin State Assembly District 90, has been endorsed by Citizen Action of Wisconsin. Shelton earned the endorsement against incumbent Staush Gruszynski who was awarded the endorsement in 2018.

Citizen Action is a grassroots nonprofit that has been advancing progressive public policy in Wisconsin for 40 years. The organization has members across the state, and a major membership base in Northeast Wisconsin, who champion environmental justice, voting rights, quality affordable healthcare for all, and labor issues.

“Citizen Action’s endorsement means a lot to me personally,” said Shelton. “Citizen Action supporters are the most engaged members of our community. To have their backing means our campaign aligns with the leaders of the progressive movement. I am looking forward to working towards our shared legislative goals if elected in August and November.”

restoring the strength of Wisconsin's unions. In addition, she has collected stories from 90th District residents affected by COVID-19 and the economic crisis.

Her opponent in the Democratic Party primary, Staush Gruszynski, was asked to step down after sexually harassing a Capitol staffer last October. After refusing to resign, Gruszynski was removed from the Democratic Assembly Caucus and relieved of his committee assignments. This means that as the Legislature responds to the pandemic and record unemployment numbers, constituents of the 90th District have no voice in the room.



"The local leadership of the Citizen Action Northeast Wisconsin Organizing Co-op, and our statewide leadership, voted unanimously to endorse Kristina Shelton because we firmly believe she is the best candidate to represent the 90th Assembly District at the State Capitol," said Robert Kraig, Executive Director of Citizen Action of Wisconsin. "Citizen Action's members and leaders are especially impressed with Kristina's commitment to govern in an open inclusive fashion, and her dedication to make real progress on big issues such as the skyrocketing cost of healthcare and initiating a climate transition that expands economic opportunity for everyone in Wisconsin."

Shelton's campaign expects to announce further organization endorsements in the coming weeks.
