MADISON - This afternoon, State Representative Staush Gruszynski (D-Green Bay), State Representative Amanda Stuck (D-Appleton), State Representative Chris Taylor (D-Madison) and Senator Tim Carpenter (D-Milwaukee) introduced legislation that would protect Wisconsin families from the harmful effects of PFAS through the ban of PFAS in food packaging applications. If passed, Wisconsin would join other eight other states including Minnesota and Michigan.



“Though drinking water contamination has been the most prevalent topic currently, since the 1940’s manufacturers have been using PFAS in food packaging as a grease-proofing agent. It is estimated that over half of our contact with PFAS comes from our food. With the list of known health concerns due PFAS exposure ever increasing, it is important that we take steps to protect Wisconsin families” Gruszynski stated.

Senator Tim Carpenter shared his support with the following, “With PFAS being linked to so many health concerns, Wisconsin families deserve that we take action on this issue. PFAS have been shown to not only lead to various cancers, but also to problems with fertility and incidents

of the thyroid. It has been a great pleasure to work with Representative Gruszynski on this important piece of legislation.”
