MADISON, WI – Today, Sen. **Chris Larson** and Democratic colleagues commemorated the 44th anniversary of *Roe v. Wade*, the Supreme Court decision that legalized abortion nationwide, by announcing an *Abortion is Health Care Resolution*.

### **The Abortion is Health Care Resolution reads as follows;**

“Republican leaders must stop their political intrusion and need to trust women to make their own health care decisions. We can’t ignore science and return to back alley abortions and jailing women. Abortion should be made affordable and accessible for all women, regardless of state, county, or zip code. Relying on scientific evidence, legislators should recognize that abortion is an essential aspect of ensuring a woman’s overall health: physically, psychologically, and socioeconomically. Because of these shared values, we introduced the *Abortion is Health Care Resolution* (LRB 1443) and hope to see support from any lawmaker who is committed to fostering healthy Wisconsin communities.
